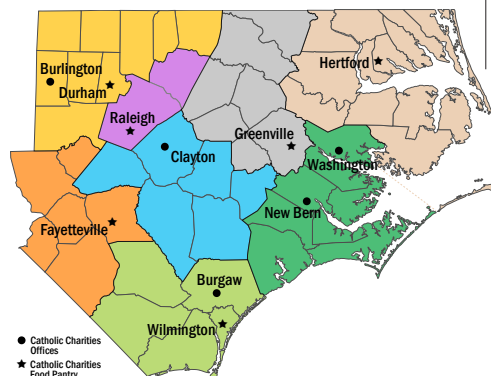


Core Programs of Catholic Charities

- † **Emergency Assistance** Provides tangible assistance to meet the basic needs of families by responding with food, baby items, prescription assistance or financial assistance.
- † **Disaster Services** Assists families, parishes and the community to plan for and recover from unforeseen environmental events that cause damage, destruction and/or human suffering.
- † **Support of the Family** Families meet with trained staff to receive a comprehensive assessment of needs, which results in either initial problem-solving for many issues, or a supported referral to connect with other community services.
- † **Legal Immigration Services** Assists immigrant families to understand the complicated immigration process. Staff provide information about the legal immigration process and assist in the completion and submission of various legal documents for those who are eligible for improved immigration status.

2017-2018 Catholic Charities *By the Numbers*

- † **54** counties served
- † Over **63,500** individuals assisted with Disaster Assistance, Emergency Assistance, Services in Support of the Family and Immigration Assistance
- † Nearly **3 million** pounds of food distributed by **6** food pantries
- † **\$30** provides a week's worth of groceries for a family of four through one of our food pantries
- † To date, **15,000** people have been assisted in the wake of Hurricane Florence
- † **\$1,000** provides a rental deposit and furniture for families needing new housing due to a disaster
- † **3,200** individuals contributed **52,000** volunteer hours



New to Catholic Charities in 2019

- † **Oak City Cares, Raleigh, NC**
Opening in April 2019, Catholic Charities is the operating agency managing Oak City Cares (OCC), a comprehensive, coordinated approach to making homelessness rare, brief and non-recurring in Wake County. In collaboration with Wake County, the City of Raleigh and the Partnership to End and Prevent Homelessness, OCC services will address housing, employment, health and hunger for the most vulnerable of our Wake County neighbors who struggle to navigate the multitude of services available. This new model brings services together, in a convenient downtown Raleigh location, to create a path for individuals and families to stable housing and renewed hope.
- † **Durham Community Food Pantry, Durham, NC**
Opening in May 2019, the Durham Community Food Pantry will serve Durham and Orange counties, helping to put an end to the 1.5 million-pound annual food shortage in this region. The facility will replicate the service model currently in practice at Catholic Parish Outreach and will be a collaborative effort, engaging multiple partners through Durham and Orange counties, to serve approximately 3,500 families per month by providing nutritional groceries.
