DEAR FRIENDS,

The past year has been a challenging experience and feels more like two stories, our success prior to the COVID-19 pandemic, and the chaotic time that followed in late winter through spring of 2020. In the fall of 2019, Catholic Charities hosted a record-breaking Gala which raised over \$250,000. We did not know it at the time, but these funds would soon become critically important as we responded to the COVID-19 pandemic.

In March of this year, everything stopped. Fear gripped the nation as this new virus spread. However, I am incredibly proud of our Catholic Charities staff and volunteers who stepped forward during this dark time and provided a light for families in need. In response to COVID-19, we quickly developed new policies and procedures to keep staff, volunteers, and the families we serve safe while continuing to distribute much needed assistance.

Our five food pantries across the Diocese of Raleigh adapted to providing groceries through a curbside distribution model and began including personal protective equipment such as facemasks with the items being distributed to families. While offices were closed, staff strived to incorporate the personal touch that sets Catholic Charities apart from other agencies in virtual communication methods such as phone calls and video conferencing.

While there are many things that are uncertain about our future with COVID-19, one thing I am certain about is that Catholic Charities will remain a leader in providing help and creating hope for our community. I am incredibly grateful to our individual donors and the foundations who stepped up over the past year to provide much needed support as we faced unprecedented levels of need throughout central and eastern North Carolina.

Through this support, and the support of over 2,963 volunteers who contributed 52,180 volunteer hours, we assisted nearly 58,000 individuals. As we move forward, I ask for your prayers and support as we continue to assist those most in need throughout the Diocese of Raleigh.





A FAMILY REUNITES WITH THEIR MOTHER AFTER SEVERAL YEARS OF WAITING

The dream of many immigrants is to become citizens of the United States and reconnect with their relatives, parents, and children through an immigration petition. Typically, according to the U.S. Citizenship and Immigration Service, petitions for immediate relatives are approved within a five to nine month time frame, but they can face delays and take longer in some cases.

One individual who faced a delay in their case was Etelinda Alfaro. Alfaro was born in El Salvador and later became a United States citizen. Like many Salvadorans, Alfaro left her country at the end of the 90's, with her brother and two sisters, to escape the political situation and social conflict that affected her country.

Alfaro wanted to bring her mom Gladys del Carmen Hernandez, 65, to live with her as a Legal Resident. Alfaro looked forward to her mothing being closer to her and her sister, who also lives in Raleigh.

Alfaro was referred by a friend from church to Catholic Charities for help with the immigration process. She needed guidance to complete the applications to reunite with her mom. Luisa Martin-Price, a Catholic Charities DOJ Accredited Representative of Legal Immigration Services, took her case.

"I never thought it would be so difficult and that the whole process would take so long," shared Alfaro as she remembers how complicated it was for her to obtain her mom's residency. "I wanted my mother to become a Permanent Resident in the United States because she has


diabetes and we wanted to take care of her, near to us."

According to Martin-Price, the delay was very unusual and the restrictions due to COVID-19 slowed the process even more.

The application was submitted to the USCIS in June of 2017 and was approved in December of the same year. However, the delay took place in the consular

In February 2020, Hernandez received her appointment to obtain her residency at the US Embassy in El Salvador, then Covid-19 arrived.

The Pandemic profoundly impacted the ability of foreign nationals of any status to travel to the United States. Beginning in February, travel restrictions were quickly implemented and as the pandemic spread, the Department of State suspended "routine visa services" at




process in El Salvador. Through the long years and challenging obstacles, Alfaro recalled that Martin-Price never lost her hope to obtain residency for Alfaro's mom.

"After asking me more than twice for my most recent birth certificate, immigration asked me to do a DNA test to verify that I was really my mother's daughter," shared Alfaro, who struggled with the many requirements of the process.

"I don't have enough words to thank Luisa for her patience and her way of handling the case, but above all, her work helping respond to emails and different documents, her attitude always was the best, the pain becomes less when someone gives one hope," concluded Alfaro. all embassies and consulates worldwide, including cancelling all "immigrant and nonimmigrant visa appointments."

This was a devastating delay to Alfaro and her mother, who had been working for many years to get this completed. When some consulates began to slowly reopen, Hernandez took advantage of the opportunity to complete her immigration process and travel as a new U.S. resident to the U.S.

When Hernández arrived, Alfaro and her siblings, as well as Hernández's grandchildren, were very happy to enjoy her love and company without the worries of time restrictions or having to return to El Salvador.

A COLLECTIVE EFFORT GIVES A FAMILY A NEW HOME AND HOPE FOR A BETTER FUTURE

Quarantining at home wasn't new to Maria de los Angeles when the COVID-19 virus descended on North Carolina. As schools and businesses shut down in March, Maria, a 45-year old immigrant from Mexico, was already facing many challenges.

In 2016, Maria was involved in a serious car accident which left her unable to walk for two years. Thanks to her perseverance and strong desire to take care of her children, she developed the strength to walk again with the aid of a walker.

When the pandemic hit, "I was already used to being at home," said Maria. "I hardly can walk and I don't leave the house much. I thought that I was never going to walk again but I managed to do it. But recently my doctor told me that my bones are getting weaker and weaker," says Maria. This year, in addition to the pandemic and chronic health challenges, Maria became a single mother to her three children, ages 5, 8, and 10.

"I couldn't pay all my bills. I didn't know how I was going to make ends meet. It was very difficult, but I never lost faith," said Maria, who is a parishioner at St. Michael the Archangel Catholic Church in Cary. "I never stopped attending church." said Maria.

Maria received support from her fellow parishioners and was referred to Centro para Familias Hispanas where program director, Marty Ferrer Hoppmann, provided help. Ferrer-Hoppmann was able to assist Maria in applying for important benefits like the Supplemental Nutrition Assistance Program (SNAP) and Work First. Maria was also connected with other assistance from Catholic Charities including receiving groceries through Catholic Parish Outreach and

housing assistance through the Support Circle program.

Maria and her children are now thriving and hope has returned to their lives. According to Maria, seeing her children happy in their new home has made her even more grateful and inspired to try new things.

"I have never lost faith," said Maria. "I know that God has placed angels to help us."

Maria's new start continues. With the ongoing help of Centro para Familias Hispanas, Maria received a donated sewing machine. After receiving sewing instructions from a St. Michael's volunteer, Maria hopes that with more instruction and materials she can someday start a small sewing business from her home.

"We will be there every step of the way to make sure she will be self-sufficient," shared Ferrer Hoppman.


